Salta Lithium Rincon Project Exploration Update

The Directors of PepinNini Lithium Ltd (PNN, the Company) are pleased to report a recalibration of the geophysical VES survey of the Company's Rincon tenement – Villanovena 1, following drilling in December 2017, which has increased significantly the basin depth potentially containing lithium bearing brine. Maiden resource calculations are currently underway and due for completion this month, June by Montgomery & Associates(Tucson, Arizona).

The survey undertaken was a geophysical Vertical Electric Sounding(VES) and was recalibrated and extended due to drilling results indicating deeper basement depth than initially interpreted from the survey in September 2017. The Company has contracted Mercoaguas, a local geophysical company to conduct the extended VES survey over the alluvial fan area previously unsurveyed which has the potential to further increase the resource. This has been the case with other projects in the Puna region such as Orocobre's Cauchari project(ASX:TSX:18 Apr 2018). The final survey report is awaited and will contribute to data for resource calculations.




Figure 1 - VES Survey Villanoven 1 - September 2017




Figure 2 – VES Reinterpretation Villanovena 1 - June 2018




Figure 3 – Villanova1 Mina Salar de Rincon – Borehole Locations and VES survey data points.
