The Board of PepinNini Lithium Limited (PepinNini, the Company) announce the resignation on 30 June 2020 of Non-Executive Director Mr Phil Clifford.

Mr Clifford has been a Director since 9 April 2013 and a Non-Executive Director since 2017, he was Exploration Manager from 2004 to 2015.

Mr Clifford will be available as a consultant to the Company given his vast experience and knowledge of the Company's projects.

The Board wish to thank Mr Clifford for his many years of service to PepinNini carried out with great integrity and wish him well with his new endeavours.

The current Board of PepinNini has a majority of independent nonexecutive directors, since the appointment of Mr George Cumplido on 23 June 2020 and Mr Andre Wessels on 9 March 2020.

This is consistent with the Board restructure announced 24 April 2020 as part of a strategic review of PepinNini.

PepinNini's focus remains Australia. While the search for a suitable acquisition is ongoing, advancing the Musgrave Project is a core focus in the near term, to deliver value for shareholders.
