# Salta Lithium Project Aquifers intersected at Rincon

The Directors of PepinNini Lithium Ltd(PNN, the Company) are pleased to report positive drilling results from one completed borehole on the Company's **Rincon Project**. Borehole PNN-VI-DW-01 intersected two aquifers, one in the near-surface of fractured halite, and a lower black sand-hosted aquifer. The borehole intersected three distinct rock type sequences. From 1m to 24.8m drilling intersected caliche(calcrete), sand, silt, clay and porous halite(rock salt) and from 26m to 69.5m black sands were intersected and intersected from 69.5 to the base of the borehole at 80m were fractured basement rocks(basalt) from which brine was also sampled.

Sixteen samples were collected by drilling packers to ensure samples are representative of the interval being tested. Preliminary density results from laboratory analysis confirm density readings taken in the field indicating brine. Analytical results for lithium grade are in preparation and certification and will be released as soon as available however due to time differences to Argentina will not be reported before COB in Australia.

The borehole has been completed as a monitoring well to support further sampling and pumping testing at a later date.

A second borehole located some 4km to the north has now been completed to a depth of 130m and samples sent to a certified laboratory in Buenos Aires, Argentina.





Figure 1 - Rincon Salar Borehole Locations
