



## PepinNini lays groundwork for community engagement in Eyre Peninsula

PepinNini has met with key community representatives in the Eyre Peninsula as an important step in its community-engagement program in the region ahead of a decision on its exploration licence applications (ELAs) in the local region.

On a visit to Port Lincoln on 24 June PepinNini Exploration Manager Suziany Rocha de Souza and Managing Director Rebecca Holland-Kennedy discussed a proposed PepinNini community engagement plan with Dion Dorward, CEO of Regional Development Australia Eyre Peninsula and Peter Scott, Executive Director for the Eyre Peninsula Local Government Authority.

The plan, which will be implemented when PepinNini's applications for three ELAs are granted, includes dedicated email and phone contact channels for local community members.

The ELAs, held by Hillside Minerals Pty Ltd now PepinNini Kaolin Pty Ltd were lodged with the South Australian Government in October, November and December last year and are expected to be granted this quarter.




Figure 1: Eyre Peninsula Kaolin Project Tenement Location

The applications cover tenements that are highly prospective for kaolin clay and halloysite (see Figure 1 for locations).

Ms Holland-Kennedy said: *"Establishing constructive partnerships with local communities is critical to successful exploration. As a prospective explorer in the region we're committed to opening a constructive dialogue with the Eyre Peninsula community. Our ELAs are pending but it is not too early to start that work and I was delighted to have had the opportunity to meet with Dion Dorwood and Peter Scott on my recent visit and establish the basis for future engagement."*
